During this time, she has provided the Committee with a regional perspective based on her extensive practical experience in incorporating the Convention on the Rights of the Child (CRC) into Latin American legal systems, as well as in assessing the impact of international standards for the protection of children's human rights on public policies, institutional designs, and national and international judicial decisions.

Dr. Mary Beloff is a professor of criminal law and criminal procedure at the University of Buenos Aires (UBA) Law School. Her outstanding scientific work has made her an undisputed leader on the issue of the human rights of children and adolescents for the academic and judicial community, both nationally and internationally. Since 2007, she has also held the position of Attorney General for Criminal Policy, Human Rights, and Community Services.

A professor of undergraduate and various postgraduate courses at the UBA Law School, she also teaches at various universities around the region. As an accredited researcher, she has served on the Advisory Councils of the United Nations Study on Children Deprived of Liberty (2018/2019) and the United Nations Study on Violence against Children (2003/2005).

Author of reference works and renowned publications in her areas of expertise, she is a member of the editorial boards of leading journals on children's rights, criminal justice, and human rights. She is also a member of prestigious national and international scientific institutions dedicated to the human rights of children and women.
