**COMMUNIQUÉ OF THE** 

ARGENTINE NATIONAL CONTACT POINT (ANCP)

for the OECD Guidelines for Multinational Enterprises

as closing of the specific instance "ACIJ v. BNP PARIBAS"

The functions of the Argentine National Contact Point (ANCP) are to promote the

Guidelines for Multinational Enterprises of the Organization for Economic Co-

operation and Development (OECD) and to contribute to the resolution of issues related

to their implementation. The OECD Guidelines for Multinational Enterprises are

recommendations issued by governments to multinational companies that operate in

adhering countries or with headquarters in said countries. The Guidelines set forth

voluntary principles and rules for responsible corporate conduct that is compatible with

applicable legislations and internationally recognized rules.

The ANCP is the authority in charge of receiving claims involving non-compliance with

the OECD Guidelines for Multinational Enterprises. The ANCP acts in compliance

with its Procedure Manual and within the framework of the abovementioned

Guidelines.

Request for specific instance: ACIJ / BNP PARIBAS

**Claimant:** 

On 4 July 2011, Dr. Ezequiel Nino, in his capacity as attorney-in-fact for NGO

Asociación Civil por la Igualdad y la Justicia (ACIJ), filed a request with ANCP

arguing that the OECD Guidelines for Multinational Enterprises had allegedly been

breached by BNP Paribas Argentina.

The object of the claim was related to the alleged criminal activity carried out by said

company with regard to improper management of assets, through the alleged

perpetration of the offences of tax evasion, money laundering and foreign currency smuggling.

In its request, Claimant asked that BNP Paribas Argentina:

- Recognize that the OECD Guidelines for Multinational Enterprises are in force;
- Explain its policy and the measures it implements to fight corruption, both internally and externally;
- Exhibit a collaborative attitude both before courts and in the context of the Specific Instance of ANCP;
- Explain its position in relation to the reported fact;
- Undertake a commitment to publish the information relevant to society as regards the corruption event in which it took part;
- Offer public apologies to Argentine society for the events that caused the filing;
- Undertake a commitment to redress the damage caused to society by collaborating with a civil society entity that promotes the construction of citizenship.

## **Proceedings:**

ANCP failed to analyze the filing by ACIJ in a timely manner; thus, no decision has been made on the request. In the context of the work to restructure and improve the ANCP, its new members made a formal offer to NGO Asociación Civil por la Igualdad y la Justicia (ACIJ), on 2 November 2016, to update its request in order to adequately consider whether or not to open the specific instance. Such offer produced no results, and so the claim under analysis is dismissed.
