CONSIDERING File No. 41.343/2012 of the Registry of the MINISTRY OF FOREIGN AFFAIRS AND WORSHIP, Executive Order No. 901 dated 7 June 2012 and Resolution No. 1567 dated 31 July 2006 of the then MINISTRY OF FOREIGN AFFAIRS, INTERNATIONAL TRADE AND WORSHIP, and

WHEREAS:

Under the resolution mentioned above, the Coordination Unit on matters related to the Organization for Economic Co-operation and Development (OECD) was created, within the then National Directorate for International Economic Negotiations, which reported to the then SECRETARIAT FOR TRADE AND INTERNATIONAL ECONOMIC RELATIONS.

The functions of the Unite included acting as a National Contact Point in accordance with the Guidelines for Multinational Enterprises,

Under Decree No. 901/2012, the organizational chart of the first and second operational levels of the SECRETARIAT FOR INTERNATIONAL ECONOMIC RELATIONS was approved.

The actions of the Directorate for Multilateral Economic and G20 Affairs, which reports to the National Directorate for Multilateral Economic Negotiations of the UNDERSECRETARIAT FOR INTERNATIONAL ECONOMIC NEGOTIATIONS, include its participation in the work of the ARGENTINE REPUBLIC, as an observer, at the Organization for Economic Co-operation and Development (OECD).

It is necessary to adapt the OECD National Contact Point to the current structure.

Under the file mentioned above, the appointment of officials as members of the OECD National Contact Point was requested.

The Directorate for Human Resources Development, the Directorate for Human Resources Management, the General Directorate for Human Resources and Organizational Planning, the SECRETARIAT FOR INTERNATIONAL COORDINATION AND COOPERATION and the SECRETARIAT FOR INTERNATIONAL ECONOMIC RELATIONS have taken the steps incumbent upon them.

The General Directorate for Legal Affairs has taken the steps incumbent upon it.

This decision is issued in accordance with the powers conferred under the Argentine Ministries Law (as amended by Executive Order No. 438/92) and its amendments and Executive Order No. 601 dated 12 April 2002.

Now, therefore,

THE MINISTRY OF FOREIGN AFFAIRS AND WORSHIP RESOLVES:

SECTION 1.- Resolution No. 1567 dated 31 July 2006 of the then MINISTRY OF FOREIGN AFFAIRS, INTERNATIONAL TRADE AND WORSHIP is repealed.

SECTION 2.-The functions of the Argentine National Contact Point are to promote the application of the Guidelines for Multinational Enterprises of the Organization for Economic Co-operation and Development (OECD) in force and to contribute to the resolution of issues related to their implementation.

SECTION 3.- Ambassador Extraordinary and Plenipotentiary Hugo Javier GOBBI (ID Number 11774300) and Minister Plenipotentiary, First Class, Roberto Alejandro SALAFIA (ID Number 13262892) and Minister Plenipotentiary, Second Class, Carlos Federico TAGLEITURRASPE (ID Number 13961426) are appointed members of the OECD National Contact Point, within the scope of the Directorate for Multilateral Economic and G20 Affairs, which reports to the National Directorate for Multilateral Economic of the UNDERSECRETARIAT FOR INTERNATIONAL ECONOMIC NEGOTIATIONS.

SECTION 4.- This decision does not entail any additional cost for this Ministry.

SECTION 5.- Be it notified and registered.
